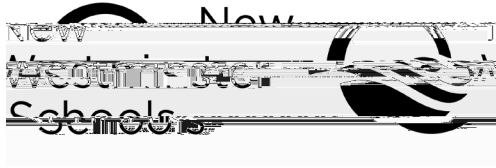

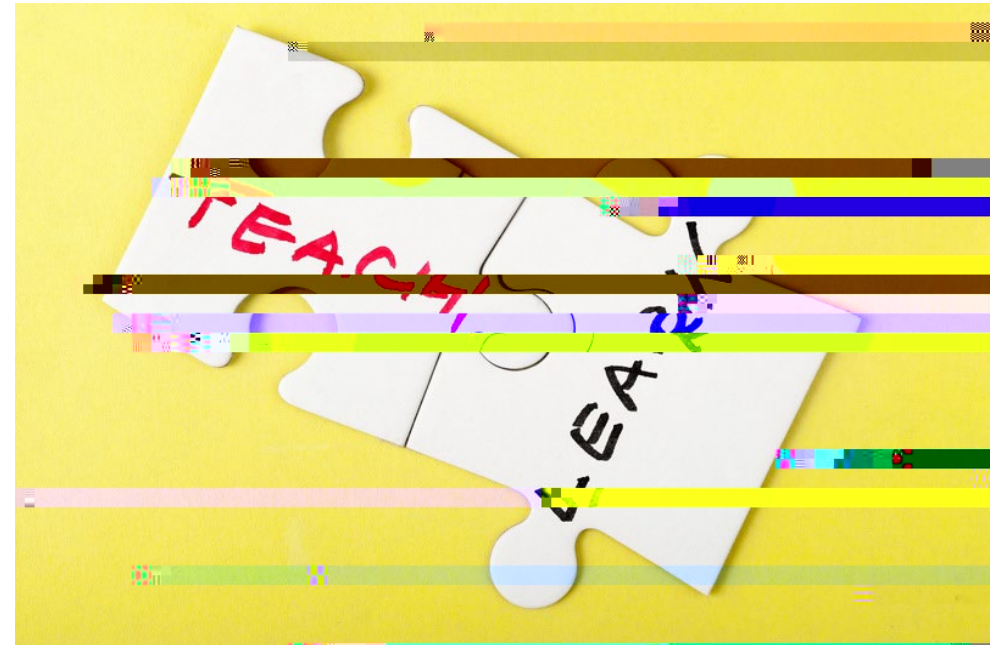

Board Authority Authorized Course Order:
School Act, sections 168 (2) (b) and (t)

BAA Course Requirements



- courses
 - guided by specific Ministry of Education procedures
 - elective credits (**grades 10-12**) that count towards graduation in 2018 Graduation Program (28 credits of 80 are must be electives)
- courses be used toward the Adult Graduation Program
- courses have pre-requisites

BAA Course Creation and Approval

- submissions in October
- Board presentation/approval:
November/December
- Ministry documents submitted: December
- new BAA courses included in course
selection process in January for a
September start
